

# Request for Bids (RFB) Goods

(One-Envelope Bidding Process)

1. The Ministry of Health of the Republic of Türkiye has received financing from the World Bank to finance the Emergency COVID-19 Health Project and intends to use a part of the proceedings for the payments under the Contract for the "Procurement of Digital X-Ray Device".
2. The General Directorate of Public Hospitals invites the Bidders, who are eligible for the supply of digital x-ray equipment to be used all over Türkiye, to submit Bids in closed envelope.

The goods in question;

3. Bids can be given for any item. The tender will be evaluated on an item-by-item basis and a contract will be made with the firm/firms whose bid is evaluated as the lowest bid on item basis.

4. Qualification criteria

#### 4.1 Post-qualification Requirements

(a) If the Bidder is the Manufacturer:

- (i) Financial Criteria

The average turnover of the bidder for the last 5 (five) years (2017-2018-2019-2020-2021) gained from activities similar to the works subject to the tender must be minimum USD 2 million. The turnovers of the works to be carried out from the beginning of 2022 (the tender year) until the tender date (bid submission deadline) shall be included in the 2021 turnover. (The turnover shall be documented with the Balance Sheet and Income Statement and certified by the

Certified Public Accountants or the tax office, and, if necessary, will be converted into the Bid Currency at the Foreign Exchange Sales Rate of the Central Bank of the Republic of Türkiye on the last day of the calculation period).

Financial Documents Issued in a Foreign Country: The Balance Sheet, Income Statement or the parts of the Balance Sheet showing that the conditions are met must be duly prepared in accordance with the relevant regulations in effect in the issuing country and certified by the competent authorities in that country. In case the above-requested balance sheet or its related parts are not submitted due to the absence of such regulation in the relevant country, the balance sheet may be certified by the competent authorities authorized to issue such documents.

(ii) Experience and Technical Capacity

The Bidder shall submit documentary evidence to demonstrate that within the last five years (2017-2018-2019-2020-2021), the Bidder, as prime supplier, has successfully completed one or more contracts that are similar to the scope of the bid, with a total value of USD 5 million or equivalent provided that at least one similar contract shall be of a value not less than USD 750,000.00 or equivalent. Documentary evidence shall include but not limited to Goods Contract Completion Certificates and/or Contracts and Invoices for contracts with public or private sector organizations. Goods contract completion certificates received as of the beginning of 2022 until the bid submission deadline shall also be considered for evaluation. All kinds of medical devices and laboratory devices' sales and their after-sales services shall be accepted as similar goods including the items subject to bidding. The Bidder shall submit the names and addresses of the institutions and organizations, who are customers for the last 5 (five) years, along with the Bid. The Purchaser has a right to apply the Bidder's customers to ask non-confidential information about the Bidder's past or ongoing contracts and Bidder's performance.

(b) If the Bidder is Not the Manufacturer:

If the Bidder is not a manufacturer but is bidding the Goods on behalf of the Manufacturer within the Manufacturer's Authorization Form (Part IV, Bidding Forms), the Bidder shall meet the qualifications set out in paragraphs (i), (ii) above.

(c) In case the bid is submitted as a Joint Venture:

The pilot member of the Joint Venture (JV) shall meet at least the followings:

- Pursuant to 3.1a(i): Average annual turnover of USD 1 million or equivalent
- Pursuant to 3.1a(ii): A similar goods contract with a value of at least USD 2 million or equivalent.

Each of the JV members must meet at least 25% of the existing requirements pursuant to a(i) and (ii).

With respect to the requirements under 3.1a (i) and (ii), all JV members must collectively meet all requirements.

5. Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" dated July 2016, and is open to all eligible Bidders as defined in the Procurement Regulations.
6. Documents will be sent via e-mail.
8. Bids must be delivered to the address below on or before 02.00 p.m. on 02.11.2022 Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be opened in the presence of Bidders' representatives who choose to attend at the address below at 02.05 p.m. on 02.11.2022.
9. Alternative Bids shall not be considered.
10. The amount of the bid security to be submitted with all bids will be USD 100,000.00 for Lot 1 (item) and USD 225,000.00 for Lot 2 (item)
11. Beneficial Ownership Disclosure Form will be used.
